## **Proposed Amendment #15 To The Community Development Block Grant Disaster Recovery Program Action Plan For Disaster Recovery**

The Town of Union is proposing amendments to the Community Development Block Grant Disaster Recovery (CDBG-DR) Action Plan for Disaster Recovery. The amendments authorize the addition of two new projects and commitment of additional CDBG-DR funds toward repairs to the Union Volunteer Ambulance Service (UVES) facility

**Amendment 1** - Increase the budget line for the UVES flood repair activity based upon the sole bid received.

Additional funding for this project in an amount not to exceed \$45,000 will be re-allocated from the unprogrammed funds line.

**Amendment 2** - Increase the budget line for the Drainage Improvements - N. Loder Ave, Endicott activity to design and construct Phase 2 of the capital improvements recommended in the N. Loder Ave. hydraulic study.

Funding for this project in an amount currently estimated to be \$600,000 will be re-allocated from the following fund budget lines:

**Amendment 3** - Create a new activity for the Johnson City Sanitary Sewer Interceptor B Separation project.

Funding for this project in an amount currently estimated to be \$435,000 will be re-allocated from the following fund budget lines:

Acquisition for Redevelopment Urgent Need:	\$110,000.00
Owner Occupied Flood Repair:	\$220,000.00
Business Flood Repair - Urgent Need:	\$ 50,000.00
Townwide Flood Feasibility Study:	<u>\$ 55,000.00</u>
	\$435,000.00
