The Municipal Electric and Gas Alliance (MEGA) is an aggregator of electricity, natural gas and renewable power. MEGA's primary objective is to achieve the most competitive prices for electricity and natural gas for its members in order to minimize the cost of energy.

Formally established in 2001, but initiated in 1998, MEGA is a Local Development Corporation that serves local governments and affiliated entities by group purchasing of electricity, natural gas and other energy products and services. It presently serves more than 30 county governments and more than 250 municipalities, including many school districts.

What is CCA?

Community Choice Aggregation

Communities may now help their residents get better energy supply options through a new program called Community Choice Aggregation (CCA). MEGA is now offering professional support for CCA, which was approved by the New York State Public Service Commission in April 2016. CCA is a way for local governments to take advantage of aggregation and competition to help residential and other small consumers to get better energy pricing. It will enhance consumer protection and be a chance for communities to set energy priorities including incorporation of renewables and other value-added energy related services. MEGA offers professional support as a CCA Administrator including designing programs, facilitating community education and outreach, coordinating competitive bidding and monitoring, and advising and ensuring compliance with NYS regulatory requirements.

Who is Constellation?

The CCA program has allowed the residents of the Town of Union to be able to have more buying power when it comes to their electricity supply rates. Currently, NYSEG does not offer residential customers a fixed rate on electricity supply. With the CCA program, the rate being offered is locked in for 2 years. That means that if the rate of electricity goes up to \$.10/kWh, you will still be paying \$0.0542/kWh.
