B. Mr. Moody provided an update about the LDC ARPA 50/50 Commercial Façade Grant of \$100,000.00 to Mr. Shia Teitelbaum, as approved on August 24, 2023, for mixed-use commercial property at 257 Main Street in Johnson City.

- C. Mr. Moody presented for discussion the review of the two separate actions regarding an amended Broome County ARPA Fund Agreement and a Broome County ARPA Fund Agreement rescission with the Town of Union Local Development Corporation.

Mr. Moody presented for discussion a proposed \$445,000.00 Town of Union ARPA Fund Agreement with the Town of Union Local Development Corporation (LDC) accepting \$445,000.00 in Town of Union ARPA Lost Revenue Replacement Funds for S.E.P.P., Inc.'s proposed residential housing project at 202-208 Garfield Avenue in Endicott and to approve the LDC's signing of such Agreement.

Provision of funds required two resolutions approving one American Rescue Plan Act (ARPA) Grant Application request. The resolutions are: (1) \$445,000.00 in Town of Union recently allocated ARPA Funds and (2) \$695,000.00 in Broome County amendment to previously allocated ARPA Funds. The total funding amount for the proposed SEPP, Inc. affordable work-force housing project in the Town of Union is \$1,140,000.00.
