MR. BROWN: So, we are here as the owners. Luckily it has been a great venture

so far. We have gotten fantastic feedback from the community. One thing that we can say is that we did have a couple of bands last year, and these specific bands did put amplified speakers outside the garage door. Going forward we are certainly not going to allow that. We don't want the residents of the community to be disturbed by our music. And we are also going to do whatever we can do to make sure that people can continue to have a great environment for people from around the community and around the state to enjoy our concerts. So one thing we are doing, and I think we will have a full idea by the next meeting, I think we are going to get adjourned tonight; but we are going to have a real plan put together to make sure that we mitigate any further issues so that nobody is disturbed by our music. In general, that is why we are here to put those points on the record. I didn't even know that the original permit didn't even allow for outdoor music. So, in full honesty, those speakers should not

have been outside.

MS. MILLER: Thank you very much. We are going to leave the Public Hearing

open till the next meeting, in the event that the weather prevented anyone from coming tonight. So we have made that decision. Is

everybody in favor of that?

MS. LANE: I think we should have a motion.

MR. POPE: Yes, I would.

MS. MILLER: Would someone make a motion that we leave the public hearing

open? Mr. Crowley made the motion to keep the public hearing open and Mr. Jaros seconded the motion. All were in favor of the motion.
