1 SUPERVISOR MATERSE: All right, so, I'm calling
2 this Special Meeting to be opened, this meeting of May
3 28th, and it's specifically for the purpose of a
4 resolution from the Employees' Committee. Sandy, will you
5 read that resolution?

6 COUNCILPERSON BAUMAN: Yes. I have a resolution
7 approving the Voluntary Furlough Memorandum of Agreement
8 with the CSCA Blue Collar and White Collar Units, subject
9 to Town Attorney approval authorizing the Supervisor to
10 execute the same, if approved, and implementing the
11 Voluntary Furlough Program upon full execution of the
12 Voluntary Furlough Memorandum Agreement.

13 MS. STALEY: Second.

14 SUPERVISOR MATERSE: You heard the resolution as
15 proposed by Ms. Bauman. Seconded by Ms. Daly. Are there
16 any comments?

17 MALE SPEAKER: I must have been asleep for a
18 minute, did we skip over the hearing of visitors.

19 SUPERVISOR MATERSE: We said we didn't need to
20 have that. (Inaudible) --

21 MALE SPEAKER: Okay. I think I went to sleep
22 for a second there and I just --

23 SUPERVISOR MATERSE: Okay.

24 MALE SPEAKER: Thank you.

25 MALE SPEAKER: And there's no visitors.

1 SUPERVISOR MATERSE: Are there any comments on
2 the resolution? Everybody is good with that? Am I
3 hearing--

5 attorneys, or did you just do that?

6 SUPERVISOR MATERSE: It's in there.

7 MALE SPEAKER: All right. Good.

8 SUPERVISOR MATERSE: Okay. Hearing no other
9 concerns, comments, let's call for a roll call vote,
10 please, Mr. Perfetti?

11 MR. PERFETTI: Staley?

12 COUNCILPERSON STALEY: Aye.

13 MR. PERFETTI: Bauman?

14 COUNCILPERSON BAUMAN: Aye.

15 MR. PERFETTI: Bertoni?

16 COUNCILPERSON BERTONI: (Inaudible) --

17 MR. PERFETTI: Is that a yes?

18 MR. BERTONI: Yes.

19 MR. PERFETTI: Augostini?

20 MR. AUGOSTINI: Aye.

21 MR. PERFETTI: And Materese?

22 MR. MATERESE: Aye.

23 The resolution passes. I see no other business,
24 and not having a second hearing of visitors, we don't have
25 any department reports to file tonight, so Mr. Augostini?

1 MR. AUGOSTINI: Oh, just -- just a bit of
2 information, the properties at Fairmont Park are going to
3 be closed -- closing tomorrow.

4 SUPERVISOR MATERSE: Correct, thank you, I
5 appreciate that.

6 MR. AUGOSTINI: So, there should be a check
7 delivered sometime tomorrow to the Town for the
8 acquisition or sale of the property, minus the option
9 payment that was made sometime ago, and I think they said
10 the construction starts on Monday.

11 SUPERVISOR MATERSE: Excellent.

12 We need a motion to adjourn at 4:42.

13 MR. AUGOSTINI: (Inaudible) --

14 MR. BERTONI: Second.

15 SUPERVISOR MATERSE: Motion to adjourn by Mr.
16 Augostini, seconded by Mr. Bertoni. Any discussions?


