#### **HEARING OF VISITORS**:

Heather Staley, 309 W. Main Street, Endicott, asked where the money is coming from to pay for the attorney in this lawsuit, how long will he be retained and how she could obtain a copy of the summary report.

Deputy Town Attorney Kurt D. Schrader said there is not a lawsuit filed as of now, but an investigation has been done and it is undetermined how long the attorney will be on retainer. He also said she should file a Freedom of Information request for the record.

Supervisor Rose A. Sotak said tax payer's money is being used.

Debra Guerin, 107 N. Wills Avenue, Endwell, asked for help from the Board to clean up a house at 2803 Watson Boulevard, Endwell that has had numerous drug overdoses. She presented pictures and a video to the Board for review.

Councilman Robert Mack said they are looking into this property under the Town's new Lock Down Law.

Todd McCarthy, 602 Ventura Boulevard, Endwell, asked about the timeline of this investigation - how and when it started and when Supervisor Rose A. Sotak was notified of the investigation.

Deputy Town Attorney Kurt D. Schrader explained the process.

Councilman Frank J. Bertoni explained that a complaint was received by the Employee's Committee which was then referred to Town Attorney Alan J. Pope. The Town Attorney may have been a possible witness to a situation or been involved in the investigation which then determined that an outside firm should be attained for an unbiased review for the report.

Kenneth Del Bianco, 3622 Matthews Drive, Endwell, asked how board meetings, work sessions and executive sessions are advertised. He further said the last three Resolutions on tonight's meeting should be already in place and ongoing annually.



Town Clerk Gail L. Springer said all meetings are advertised on the bulletin board and the Town website.

Councilman Thomas R. Augostini said the workplace violence training is done annually by the Deputy Commissioner of Public Works for Environmental Services.

Bridget Kane, 39 Jane Lacey Drive, Endicott, asked for an explanation on how the hold process works and how the person the Resolution pertains to can be the one requesting the hold.

Councilman Thomas R. Augostini said that the Town follows the Robert Rule of Order that is adopted at the Reorganizational Meeting. He explained that under the rules, any Board member can hold over any item, at which time, it will be automatically carried over the next Board meeting. The item held over cannot be held over again, but it can be tabled. He further explained that if the item is tabled, an explicit length of time must be determined for the table and it must be by a majority agreement.

Heather Staley, 309 W. Main Street, Endicott, asked Supervisor Rose A. Sotak if she was responsible for her own attorney fees.

Supervisor Rose A. Sotak said this was undetermined at this time.

As no one else wished to speak, Supervisor Rose A. Sotak closed the second Hearing of Visitors.
