TOWN OF UNION BOARD MEETING

October 18, 2017

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, October 18, 2017 at 7:30 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

Linda Jackson, 209 E. Franklin Street, Endicott, asked if the Town could enforce the clean up or demolition of the buildings at 1-3 N. Duane Avenue, Endicott.

Supervisor Rose A. Sotak questioned if they are in the Village of Endicott and said Councilman Thomas R. Augostini will look into it.



David McDonough, owner of Country Pines – The Pines Pavilion and Event Center, Endicott, spoke about his ongoing code enforcement issues and said he was informed that the Town received a letter from Hinman, Howard & Kattell, threatening that a lawsuit should be filed against him if something did not change with his property.

Councilman Thomas R. Augostini said the letter should not be taken as a threat of a lawsuit, but as an indication that the use of the property needs to be in compliance with the codes.

Deputy Town Attorney Kurt D. Schrader said he does not know of any lawsuit being filed. He explained to Mr. McDonough that he is in the position to prove that the use of his property is in compliance with the codes, and if it is not, that he can file for a variance with the Zoning Board of Appeals.
