<u>Resolution</u> to authorize a waiver of all building permit fees for the Town of Union sponsored CDBG-DR funded Johnson City Water Treatment Maintenance Building, located at 44 Camden St, Johnson City.

<u>Resolution</u> to issue a Negative Declaration under the State Environmental Quality Review Act (SEQRQ) for the West Creek Bank Stabilization project. The Supervisor, Deputy Supervisor, or other Town official designated by the Town Board shall be authorized to sign the required SEQRA forms. The project is funded through the CDBG-DR grant. The required environmental review under the National Environmental Policy Act has also been completed and the Town will issue a Finding of No Significant Impact – Request for Release of Funds for publication on February 8, 2018.

**Motion** to accept the Change of Zone Petition from Industrial (I) to Urban Multi-Family (UMF) for 26 Kentucky Avenue, to renovate an existing school into approximately 71 multifamily residences, and to refer it to the Planning Department to make all necessary referrals under Section 239-I and –m, and to forward the Rezoning application to the Planning Board for an advisory opinion.
