### TOWN OF UNION BOARD MEETING

### March 6 2019

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, March 6, 2019 at 7:00 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

### HEARING OF VISITORS:

Linda Jackson, Village of Endicott Trustee, is excited to inform the Board that the Village is interviewing companies to do a water study on all of their wells, which they hope to be completed by August 1<sup>st</sup>. She said as of right now, the Ranney Well is the only well that does not have iron in it. She further said that when chlorine is added to the wells that have the iron in them, it causes the water to turn orange.

Pam Brigham, 409 N. Page Avenue, Endicott, said she was at the last meeting to speak about a nuisance property at 407 N. Page Avenue and that she invited other neighbors to speak about the problem.

Susan Naylor, 408 N. Page Avenue, Endicott, said she lives across the street from the property and she is selling her house because she can't tolerate the problem anymore. She said the neighbors are constantly working on cars with loud power tools late at night and they carry guns out on the porch. She also said because of the firearms, she is afraid for the children in the house and the neighbors.

Michelle Colburn, 507 Birdsall Street, Endicott, said she lives around the corner from the property and that the noise is bad at all hours of the night. She also said they are always in the street, parking cars on both sides of the street making it hard to drive through, and have

people in and out of the house at all times. She further said she can't enjoy spending time outside on her porch because of the noise and for fear of being hurt by them.

Glennis Lamonica, 404 N. Page Avenue, Endicott, also complained about the noise at night that goes as late as 3:00 or 4:00 AM, working on vehicles in the road, and garbage all over their yard. She said she has called the police to report someone from that house chasing a person with a firearm and also said the police are there at least five times a week. She further said her elderly neighbor is afraid to come out of her house.

Lindsay Raub, 400 N. Page Avenue, Endicott, said that the noise and banging at night keeps them awake. She also said she witnessed an adult chasing a 3 year old child around the house while screaming profanity. She is worried for the welfare of the children and the neighbors.

Pam Brigham, 409 N. Page Avenue, Endicott, said two families were not at the meeting tonight to voice their concern out of fear of retaliation.

Wes Miga, Union Center Fire Company, said they have been working for over a year with different insurance agencies to try to get a reduction in the rate they pay for Workers Compensation, which due to the nature of firefighting, is very expensive. He said they appreciate all the work that Comptroller Laura J. Lindsay did by negotiating with Haylor, Freyer and Coon to get a significant rate reduction for them, even working on Christmas Eve to get this done to be effective on January 1st.

Dan Loiselle, 3201 Wayne Street, Endwell, asked for an update on the status of the BAE site in Westover.

Supervisor Rick A. Materese said a public meeting is scheduled for March 7, 2019 at 6:00 PM at the Town Office Building regarding this subject and to look on the Town Website for further information regarding it.

As no one else wished to speak, Supervisor Richard A. Materese closed the first Hearing of Visitors.



### HEARING OF VISITORS:

Michelle Colburn, 507 N. Page Avenue, Endicott, asked what the Board is going to do about their neighborhood. She said people are leaving, living in fear and afraid of retaliation.

Councilman Frank J. Bertoni said the Town is doing everything they can to make this law effective. He said the neighbors have to call Code Enforcement for code violations and if there are other problems, they must call the police. He also said that if it appears the violations are not being corrected, they can be used against them to try to get it locked down. He further said the Town will try to meet with the landlord again to get these issues resolved.

Supervisor Richard A. Materese said there isn't a person on the Board who does not want to remedy this situation. He said it is hard because the Town does not have a police department to patrol the area and unfortunately the Town has no authority to do police work.

Cheryl Chapman, Village of Endicott Trustee, said she co-wrote the lockdown law in Endicott and said the Code Department works with the Police Department on the issues. She said a lot of the time the landlords are absent and do not know what their tenants are doing and once they are notified by the Code or Police Departments, they remedy the problems quickly. She said they are having great success with their lockdown law and new codes.

Councilman Frank J. Bertoni explained why the law is being revised. He said the hope is to resolve the issues at the first step, by meeting with the landlord and not have to go to court, but the law has to be strong enough to get past any challenges.

Supervisor Richard A. Materese said they are attempting to meet with the landlord but cannot guarantee he will come in.

Susan Naylor, 408 N. Page Avenue, Endicott, asked what it would take to have the Village of Endicott Police patrol their area.

Supervisor Richard A. Materese said they would have to get a neighborhood petition signed and present to the Village of Endicott Board asking to extend the coverage area for Police.

Tim Brigham, 409 N. Page Avenue, Endicott said the landlord has been informed by the neighbors of the problems, but he chooses to ignore them since he is getting his rent.

Glennis Lamonica, 404 N. Page Avenue, Endicott asked what the noise ordinance is in the Town.

Councilman Thomas R. Augostini explained the noise ordinance is for the decibel level and there is not a time restriction in it.

Tim Brigham, 409 N. Page Avenue, Endicott, asked if the Town owned a decibel meter and if the problem is at night, how would it be monitored since the Code Enforcement Office does not work at night.

Pam Brigham, 409 N. Page Avenue, Endicott, said the landlord is not an absentee landlord; he lives in Endicott.

Frank Chernega, 461 Payne Road, Endicott, said he sent an email to the Board regarding solar farms, and wanted to know what the Board thought about them.

Supervisor Richard A. Materese said the moratorium on solar use in the Town is to give the Town time to develop regulations on ground panels, which the current code does not address.

Ron Dellapenta, 506 N. Page Avenue, Endicott spoke about a vacant house next door to his that is being foreclosed on. He said that he has been shoveling snow and mowing grass there, but wanted to know whose responsibility it is to take care of it.

Deputy Town Attorney Rosemarie Pope said it is the bank's responsibility to take care of it and if they are not, then notify the code enforcement office of the violations.





As no one else wished to speak, Supervisor Richard A. Materese closed the second Hearing of Visitors.
