#### **TOWN OF UNION BOARD MEETING**

#### March 20, 2019

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, March 20, 2019 at 7:00 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Richard A. Materese, Councilman Thomas R. Augostini, Councilman Frank J. Bertoni, Councilwoman Sandra C. Bauman, Councilwoman Heather R. Staley.

Also in attendance were Broome County IT Director James Dutcher and Zoning Board of Appeals member Giuseppe Roberto.

Supervisor Richard A. Materese opened the meeting with the Pledge of Allegiance to the Flag.

#### **PUBLIC HEARINGS:**

A Public Hearing was called for on Wednesday, March 20, 2019 at 7:00 P.M. to solicit public input for inclusion in the Federal Fiscal Year 2019 Community Development Block Grant (CDBG) Annual Action Plan.

Debra Kerins, Director of RSVP – Retired Senior Volunteer Program through Catholic Charities, 252 Main Street, Binghamton, said they are submitting a proposal for funding. The mission of the program is to enlist people 55 years or older to stay active and involved with their community by matching them with nonprofit organizations in volunteer positions, thereby, allowing seniors to stay in their own homes instead of going into nursing homes. She said some of the volunteer positions include exercise, fall prevention and independent living classes at the senior centers, Meals on Wheels delivery, a phone calling program that checks on seniors in their homes to ensure they have whatever services they need, and an Elder Justice program.



Preston Evans, ACHIEVE, spoke about their Summer Program that is designed for students age 5 to 21 with various disabilities and financial needs. He said the group's mission is to provide an enhanced quality of life for children with disabilities, and the Summer Program is designed to fill the educational gap over the summer break for the students while still participating in programs that maintain their academic progress through drama, music, cooking, physical activity, arts & crafts and field trips. He also said they provide a Work Study Program for students ages 14 – 21 that teaches valuable vocational skills, while earning a paycheck. He further said the greatest expense incurred is related to personnel staffing in order to follow the required guidelines. The CDBG funding helps to offset these costs. He thanked the Board for their consideration for the funding.

Casondra Hamilton, Executive Director, Actions for Older Persons, Binghamton, thanked the Board for their continued support over the years. She said their mission is to provide advocacy, individualized counseling, and unbiased information to empower older adults and their families to make informed decisions. She provided statistics on the numbers of people 65 and older that benefit from AOP's Senior Health Insurance Counseling, Assistance Program and Long Term Care Ombudsman Program.

As no one else wished to speak, Supervisor Richard A. Materese closed the Public Hearing.

#### **HEARING OF VISITORS**:

Paul Gonzalez, 508 June Street, Endicott, relayed a message from Mitch Curatolo, 1010 Autumn Drive, Endwell. He said Mr. Curatolo is not well and cannot attend the meetings, but wants the Board to know he is still unhappy with the lack of progress on the cleaning up of the problem house on Autumn Drive.

At this time, Supervisor Richard A. Materese welcomed Mr. Dutcher to the meeting and invited him to speak.



Jim Dutcher, Broome County IT Department, spoke on behalf of County Executive Jason Garner, and gave an overview of the State of the County address. He said the talk was geared around two words - partnership and collaboration; with two examples of this being the demolitions of the EJ building at 1 North Page Avenue and the Endicott Inn on Washington Avenue. He said County Executive Jason Garner encourages shared services between towns and other government agencies. He also said there are 4000 reported job openings in Broome County and they are working with Workforce to try to fill these positions. He went on to say that there is a new effort to get more activity going at the Broome County Airport. He spoke on the new Veterans consolidated services building that is being put in the former Vestal Hills Country Club and said they are very excited to offer this service to the Veterans. He spoke about the 50% decrease in heroin overdoses in Broome County and credited District Attorney Steven Cornwell and staff with this reduction. He went on to talk about the 3% decrease in the State Budget that will affect Counties and Towns such as the funding of the AIM program, the costs for early voting and lead poisoning testing.

Supervisor Richard A. Materese asked if the 50% decrease in overdoses were for overdoses that resulted in deaths or overdoses with the patients being revived by Narcan.

Mr. Dutcher said it was a decrease in fatal overdoses.

Councilman Frank J. Bertoni asked if County Executive Garner has a plan to fund the AIM program if the State puts it on the County.

Mr. Dutcher said he is unaware of a plan, but will take this back to County Executive Garner to get an answer.

Carol Laskoski, 37 Edwards Street, Johnson City, said she opposed to the early voting and the expenses that will be incurred from it.

As no one else wished to speak, Supervisor Richard A. Materese closed the first Hearing of Visitors.
