TOWN OF UNION BOARD MEETING

January 20, 2021

The Regular Meeting of the Town Board of the Town Of Union was held on Wednesday, January 20, 2021 at 7:00 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York and via Zoom.

Town Supervisor Richard A. Materese opened the meeting with the Pledge of Allegiance to the Flag.

HEARING OF VISITORS:

Amanda Dorrell, 115 Patio Drive, Endwell, Board member of the Highland Greens Homeowners Association, said she's glad to see that their petition was included on the agenda for this evening's meeting. She said she experienced a sewage backup in her basement on Christmas Day that has affected her mentally, physically, with which she is still having issues, and financially. She hopes that the Town of Union can come to a resolution with the complex to resolve this ongoing issue.

Tom Fabrizio, 213 Patio Drive, Endwell, said he appreciates the Board for taking the time to listen to them. He said that there were 14 people affected that day, with half of them being senior citizens who live in their retirement homes. He said this has taken a toll on their community and this is not the first time this has happened. He, himself, was affected with a \$25,000 bill for damages and said they are asking the Town to devote some resources to determine the source of the problem. He also said they are getting waste from Weis in their basements; and that if they can find out the source of the problem, this may lead them to a conclusion to fix it.

Maryann Harkness, 201 Patio Drive, Endwell, also a Board member of the Highland Greens Homeowners Association, said they have heard by several people including your Attorney that our sewer backup flooding problem might not be the responsibility of the Town of Union because our sewer system is private. She said this statement is completely untrue. She referred to a document from 1984 that was presented to the Town from Hinman, Howard & Kattell. She pointed out the section of the letter on sanitary sewer and storm sewers indicating that their entire sewer system was installed, tested and approved by the Town of Union. She said it further stated that the developer was required by the Town to install a specific size and type of piping, and to maintain the system for one year of operation after which the Town accepted the system and took over responsibility to maintain it. Mrs. Harkness additionally asked if they had a private sewer system, why all 49 homeowners receive a bill for water and sewer usage. She further said she and her husband have experienced 7 sewer backups in their home that have required professional cleanup crews to remove the toxic waste, tear out everything that was touched by the waste and clean up their home. She said this could happen anytime again because the Town has not fixed this 30 year old problem and the owners feel ignored and not represented.

Steve Mahonski, 111 Patio Drive, Endwell, said he has been a resident for a few years at this address, and said he heard rumblings before he purchased the property, but made the purchase anyway. He said he has experienced a couple of backups and the sewage has affected his health, not a pleasant situation for him. He said he saw things coming out of his toilet that he never would have expected, lettuce butts, jelled grease, product labels and vegetables, not the normal sewage. He further said it seems to be coming from the Park Manor Plaza, not sure how it is getting there, but it is very concerning. He thanked the Board for their time and consideration in this matter.

Sandy Johnson, 313 Plaza Drive, Endwell, said she has been a resident in the development since it was built 35 years ago. She said the most pertinent issues the Board should be listening to is the investments that they all have put into their homes and the losses they have

experienced. She said they have lost others in the development that have moved away because of this problem. Mrs. Johnson said she and her husband have experienced many losses in their home from the backups and since the first backup, they have not been able to use their basement. She also said all of their belongings are in their first floor and their garage. She asked the Town to please do something to correct this problem. She thanked the Board for listening.

Jim Lozzi, 308 Patio Drive, Endwell, President of the Highland Greens Homeowners Association, said there is a simple fix to this problem. He said Patterson Creek runs along the western and southern borders of their development, which separates them from Park Manor Plaza. He explained that this swale, along with the one at Patio Drive and Pleasant Drive, flow into Patterson Creek and when it reaches at certain height from rain, overflow or snow melts, it mitigates to a sewer manhole at the southeast corner of their property, adjacent to the Ukrainian and Presbyterian churches on Farm to Market Road. The reason for the increase of flow is that we have 2 storm sewer drains located on Pleasant Drive that flow into this swale and then into Patterson Creek. As a result, the water level in the creek rises. He said the elevation maps show the manholes in the development are at a difference of 3 feet from the creek. In the past, the Association has used Cervoni Brothers Construction to dredge the creek, because Mr. Akel/Park Manor Plaza was experiencing flooding too. They removed in areas 3-5 feet of the creek bed and could not go any deeper because a sanitary sewer line is there through an easement, which takes care of Park Manor and the Park Manor Plaza. He said Town of Union officials came to look at and scoped their sanitary sewer system, finding it in perfect condition, which he agrees with since he was there when they did it. He said the problem is a certain manhole cover on their property, and maybe others on their street, that are bolted manhole covers and over 50 years old. The seal is broken and needs to be replaced; a simple gasket would fix the problem. He also said it's a backflow problem caused because of the difference of the 3 feet from their storm sewer influx and the creek. He said that Mr. Akel put in a 6 inch PCV check valve on the Plaza side to prevent this backflow into his property. Mr. Lozzi said he would be happy to meet with anyone to discuss the issue.

Councilman Frank J. Bertoni asked if the Board was allowed to meet with Mr. Lozzi to see the manhole and what's going on.

Town Attorney Alan J. Pope said that certainly as elected officials you can meet with anyone, but said there was a threat of litigation from them and that is why he is requesting that any meetings be funneled through the Town Attorney first, so there is no misunderstanding. He also said to communicate with the group to meet together.

Tom Fabrizio, Highland Green Homeowners Association, said they are not threatening litigation; they just want to meet to discuss what can be done.

Attorney Alan J. Pope said on January 15, 2021, he received from Mrs. Harkness a single screen shot of a document or agreement. He asked Mrs. Harkness on January 16, 2021 to send him the complete document. He said a search in the Town of Union has not uncovered

any easement document or agreement. He asked again if someone could please make a copy and get it to him.

Mr. Fabrizio said he would send it as soon as possible.

As no one else wished to speak, Supervisor Richard A. Materese closed the first Hearing of Visitors.
