TOWN OF UNION BOARD MEETING

June 2, 2021

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, June 2, 2021 at 7:00 P.M. in the Town Board Room, 3111 E. Main Street, Endwell, New York and via Zoom.

SALUTE TO THE FLAG:

Supervisor Richard A. Materese opened the meeting with the Pledge of Allegiance to the Flag.

PUBLIC HEARINGS:

A Public Hearing was called for on Wednesday, June 2, 2021 at 7:00 P.M. to consider a moratorium on Marijuana Retail Sales and On-Site Consumption Sales and Related Zoning Issues.

Supervisor Richard A. Materese explained that the Public Hearing is not about debating whether the Town will opt in or out of the sales of marijuana, but it is to decide if an extension of time is needed to assess our codes to make sure we are set with them when we decide what we are doing.

Town Attorney Alan J. Pope explained the moratorium would be a time period to study the code to see how it relates to a new activity or use and to make sure if we need to adjust our codes for the new activity.

Charlie Wage, 281 Twist Run Road, Endicott, asked if the Town does not go for the moratorium, when will we be able to talk about it and how is the Town going to get around the federal marijuana laws that make it a Class A felony.



Supervisor Richard A. Materese said there will be time later to talk about it once we set up the code. He also said the Town has until the end of the year to decide if they are opting in or out.

Town Attorney Alan J. Pope said the moratorium is too look at all aspects of the code, and to see if it the new activity can fit in the current zoning. It is the same as we would do for bars, if they are new to the Town we would look at the number of parking spaces, setbacks and anything related to codes. He further said there will be an informational Public Hearing at a later time for the discussion of opting in or out.

Mr. Wage asked if New York State is subject to the Federal laws and shouldn't the Town know if you want the law before they decide how to adjust the codes for it.

Town Attorney Alan J. Pope said the moratorium is the same as what they did for the solar or wind energy. He said that not having a moratorium to study the codes and zoning is not right and the Town could get overwhelmed.

Supervisor Richard A. Materese said the moratorium would give us time to have a Public Hearing to listen to the residents as to whether they want it or not.

Mr. Wage asked how much time the Town would need before they made their decision.

Town Attorney Pope said they would listen to the input from the residents and then decide. He also said there is no set time, and it could be three months, but some moratoriums like the ones for solar and wind energy, have taken longer.

Peter Shafer, 1543 Union Center Maine Highway, Endicott, said he is against holding a moratorium and that the Town is giving the wrong message to businesses. He further said there are no licenses issued or will be issued for a long time, so the Town has enough time to discuss this without a moratorium.

Carol Layton, 123 Wilson Avenue, Endicott, asked for an explanation of the moratorium and said she is against the sale of marijuana and wants to have the Town restrict it anywhere near schools. She does not want the Town to do what the Village of Endicott did for the Bryne Dairy to be able to sell cigarettes near the school.

Supervisor Richard A. Materese said these are some of the things we will be looking at.

As no one else wished to speak, Supervisor Richard A. Materese closed the Public Hearing.
