Councilwoman Heather R. Staley explained the reasoning behind the decisions to support bonding for the resurfacing of the roads and the purchase of the dump truck. She said we can't put off resurfacing the roads and doing maintenance to them. The more we put it off, the more in disrepair they become and the more expensive it is in the long run. She also said the dump truck is replacing one that is about 20 years old and according to our mechanics, is on its last leg and hard to get parts for. She added that the Board put a lot of thought into this, before spending the tax dollars.

Councilman Frank R. Bertoni asked if the public would be able to attend the meetings in person again and if the building would be opened since the yellow zone has been lifted in Broome County. He said the Board has to come up with a plan to reopen.

Supervisor Richard A. Materese said the public would be allowed to attend the meetings, but the building would remain closed for an undetermined amount of time.

Councilwoman Sandra C. Bauman said we are out of the yellow zone right now, but what does that mean? She said she wants everybody attending a meeting to be required to wear a mask at all times.

Councilwoman Heather R. Staley said she is not concerned with people attending the meetings, but said she is not sure it is a good idea to open the building. She wants to ask the employees, such as the Clerk's Office who will be dealing with the public coming in and out, how they feel about it first.

Councilman Thomas R. Augostini said he is concerned about opening the building. He said there are no margins for employees. He said with the limited staff, there would not be anyone to cover an office if someone tested positive and the rest of the employees had to quarantine for two weeks. He further said, we are providing a service now, it may be at a limited capacity, but without the employees to cover, we just cannot do it.

Supervisor Richard A. Materese said what we have now is working, it is not convenient, but it's working. He went on to say, that the budget process was difficult with the sales tax

revenues down, and when people come into this room looking at ideas, we should listen to them and think outside the box. This process should be done, not just do nothing, leaving things as is.

ADJOURNMENT:

Moved by Augostini, seconded by Bertoni to adjourn the meeting. Carried.
