RE: Notice of Violation – Untreated Wastewater Surface Discharge Village of Endicott and Town of Union, Broome County SPDES Permit No. NY0027669 (Village of Endicott) POSS/POTW ID - NYS700029, NYS700030 (Town of Union)

Dear Mayor Jackson and Supervisor Materese:

This letter serves as a Notice of Violation for Sanitary Sewer Overflow ("SSO") that have occurred from a force main associated with the abovementioned permits under Section 17-0501 of the New York State Environmental Conservation Law (ECL) and regulations set forth in Title 6 of the New York Code of Rules and Regulations (NYCRR) Part 750.

On May 10, 2022, an anonymous tip was reported to the New York State Department of Environmental Conservation ("Department") staff that raw sewage was flowing into the Susquehanna River (a Class A river) south of Riverhurst Cemetery. Department staff followed up with an inspection and confirmed that an active SSO event was underway.

The SSO location prevented timely response by the Village of Endicott ("Village") and Town of Union ("Town") due to the presence of an approximately 20-foot pile of construction debris on the Town's easement where a 24-inch force main and gravity sewer are buried. An Inter-Municipal Agreement between the Village and Town allocates responsibility to the Village of Endicott for maintenance of the force main within the Town's easement. Since the property owner is obligated to maintain the Town's easement at all times for clear access, the Town promptly contacted property managers of Riverhurst Cemetery regarding the debris, and removal was initiated on Friday, May 13. The construction debris was moved allowing Village contractors to expose the force main on Tuesday, May 17. Department staff from the Division of Water arrived onsite that same day, however the origin of the SSO could not be located

as there was no observed active discharge. On May 26, the Village informed the Department the source of the SSO is an approximate 2-inch hole on the bottom of the 24-inch force main which they were working to repair. Final repair to the force main was completed on May 31, 2022.

The following violations were observed:

VIOLATION – Untreated Wastewater Surface Discharge:

Pursuant to 6 NYCRR Part 750-2.8(a)(1) and Environmental Conservation Laws 17-0803, 17-0501, and 17-0511: The use of existing or new outlets or point sources, which discharge sewage, industrial waste or other wastes into the waters of the State is prohibited unless such use is in compliance with standards, criteria, limitations, rules, and regulations promulgated or applied by the Department pursuant in this article.

Violation – Condition of Force Main

Pursuant to 6 NYCRR Part 750-2.8(a)(2)(i): The permittee shall, at all times, properly operate and maintain all disposal facilities, which are installed or used by the permittee to achieve compliance with the conditions of the permit. Proper operation and maintenance, as a minimum, includes a preventive/corrective maintenance program for all critical facilities and systems of treatment and control (or related appurtenances) which are installed or used by the permittee to achieve compliance with the conditions of the permit.

SCHEDULE OF COMPLIANCE:

The force main has exhibited numerous leaks that require immediate and costly repair within the past 4 years. Two events were reported in May and September of 2021. The following actions shall be completed:

By no later than September 1, 2022, provide a schedule to address the following items:

- 1. Confirm there are no obstructions along the entire length of the force main alignment and develop a plan to clear the easement of any obstructions to prevent delays in addressing potential, future SSOs and maintenance of the force main.
- 2. Submit to the Department an Emergency Response Plan (ERP) that includes the following:
 - a. Updated contact information and procedures for responding to and minimizing sanitary sewage overflow events;
 - b. Updated inventory of all necessary equipment and supplies needed to respond to emergencies; and,
 - c. Procedures for routine verification to ensure that critical parts necessary for force main repairs are continually in inventory for immediate availability.

3. Submit to the Department an Engineering Report evaluating the integrity of the force main. The report shall include: 1) a description of the force main detailing its age, material, and maximum capacity flowrate; 2) a summary of historical non-compliance events (i.e. failures/breaks/leaks, etc.); 3) a summary of any known I/I source; 4) a layout/drawings of the existing force main with locations and information of junctions with other pipes in the collection system; 5) a current Inter-Municipal Agreement between the Town and Village that clearly identifies the responsible parties for ownership and maintenance of collection sewer system; and, 6) a proposed schedule for improvements to the force main which will be implemented to prevent recurrence of the non-compliant events.

If approved, the Department will incorporate the proposed Schedule for Completion of the compliance items above into a formal enforcement action. This action may or may not include both municipalities.

Please take notice that the Environmental Conservation Law ("ECL") 71-1929 provides that any person who violates any section of titles 1-11 and title 19 of Article 17 of the ECL shall be liable for a civil penalty, punishable by a penalty of not to exceed \$37,500 per day for each violation.

Please also be advised that this matter has been referred to the Department's Division of Legal Affairs for formal enforcement action that may include the collection of financial penalties for environmental violations.


