**PUBLIC HEARING NOTICE**

The Town of Union is proposing amendments to the Federal Fiscal Year (FFY) 2021 Annual Action Plan for the Community Development Block Grant (CDBG) program. The first proposed amendment will add funding from the FFY 2021 Unprogrammed CDBG funds to the Village of Johnson City, NY Grand Ave Phase 5 Project. The second proposed amendment will add funding to the Odell – Oak Hill Avenue project from FFY 2019, 2020, uncommitted funds from CDBG 2021 and 1<sup>st</sup> Time Home Buyers Program.
