## FUNDING CATEGORY ALLOCATION PLAN AMENDMENT LOST PUBLIC SECTOR REVENUE REPLACEMENT STANDARD ALLOWANCE OPT-IN

In accordance with United States Treasury guidelines, the Town of Union is offering the opportunity for public comment on proposed changes to the previously adopted American Rescue Plan Act (ARPA) funding category Allocation Plan. The Final Rule for ARPA allows grant recipients to opt in to a standard allowance to replace lost public sector revenue of up to \$10,000,000 in aggregate, not to exceed their award amount. The Town Board intends to opt-in to the standard allowance. This standard allocation will replace the initial allocation of \$1,500,000 originally estimated by the Town of Union.

Recipients may use funds up to the amount of revenue loss for government services; generally, services traditionally provided by recipient governments are government services, unless Treasury has stated otherwise.
